Subject: Release of salary of SKUAST(K) employees for the month of April, 2019 by or before Monday 13th of April, 2019

In response to your communication No.AU/SK/JCM/2019/567-77 dated 9.5.2019 addressed to Hon'ble Vice-Chancellor, you are being informed as under:

Being Chairman, JCC does not mean you will try to hijack the system and be a law unto yourself. Law will not hesitate to follow its own course of action as and when situation would demand to safeguard the interests of the Institution. The style and contents of aforesaid letter of yours are dictatorial in nature. You are therefore asked to maintain officialism while corresponding with the Chief Executive of the University.


The strike called on 09.5.2019 regarding non-release of salary for the month of April, 2019 was illegitimate owing to the reasons that the University is receiving grant-in-aid from the State Government for meeting the expenditure on salary etc. which was under process for release.

In this regard you stood informed by the University vide No.AU/Adm/NTEA/2019/1911-76 dated 8.5.2019 that delay in non-release of salary for the month of April, 2019 by a few days occurred only due to non-receipt of funds from the State Government owing to Darbar Move from Jammu to Srinagar. You were also informed that the University is vehemently pursuing early release of funds from the State Government. Despite assurances and having provided valid reasons, you even then pursued your agenda of agitation and brought the working of the University to stand still for a day. Not only this, you assembled and instigated the employees inside the Administrative Block against the officers at the helm of affairs who were present in their offices which is an unlawful act on your part.



It is hereby reiterated that in future also salary of employees will be disbursed by the University only after funds for the purpose are received in the accounts of the University. No one will be permitted to hoodwink the peaceful atmosphere of the University on this account.

In view of above you are hereby put on caution not to resort to such an unlawful/unwarranted act on any of the Campii or Research Stations/Units of the University. In that event the University will not hesitate to invoke relevant provisions of J&K Government Employees Service Conduct Rules.
