**Subject: Final opportunity for Document Verification-cum-Counselling of candidates provisionally allotted seats in Undergraduate Degree Programmes (Domicile of UT of J&K) for Academic Session 2026-27.**

**NOTICE**

In continuation of this office Notice No.AU/Acad./2026/U-09/9758-75 dated 18.09.2026 regarding Document Verification-cum-Counselling of candidates provisionally allotted seats for admission to various Undergraduate Degree Programmes (Domicile of UT of J&K) for the Academic Session 2026-27, it is hereby notified that candidates who, for reasons/circumstances beyond their control, could not appear before the Counselling Board on the date and time prescribed for their respective programme are being afforded one-time final opportunity to complete their Document Verification-cum-Counselling.

Accordingly, such candidates may appear in-person before the Counselling Board on **Monday, 28.09.2026 (10.00AM)**, at Nund Reshi Hall, SKUAST-Kashmir, Shalimar Campus, along with all requisite original documents and one set of self-attested photocopies, as prescribed in the aforesaid Notice.

It is further notified that after the close of office hours on **28.09.2026**, any seat remaining unconfirmed due to non-reporting/non-completion of Document Verification-cum-Counselling by the concerned candidate shall be deemed to have been not opted for by the candidate and shall accordingly be released for inclusion in the seat matrix (vacancy pool) for the 1st Up-gradation-cum-Counselling Round, to be conducted as per the procedure already notified by the University.

Candidates are, therefore, advised to avail this final opportunity at their own risk and responsibility. Failure to appear and complete the prescribed Document Verification-cum-Counselling by the stipulated deadline shall result in forfeiture of the provisional allotment, and the University shall be at liberty to include the resultant vacancy in the subsequent counselling process.

All other terms and conditions contained in the aforesaid Notice dated 16.09.2026 shall remain unchanged.

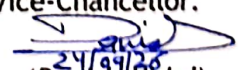
