

NOTICE

In continuation of Admission Notification No. AU/Acad/BAT/BHT-2026/B-03(IV)/19861-99 dated 25.03.2026 issued for admission to the One-Year Basic Agriculture Training (BAT) and Basic Horticulture Training (BHT) programmes for the Academic Session 2026-27, it is hereby notified for information of all concerned candidates that an online window for submission of programme and district preferences shall remain available on the University website from 21.05.2026 (10.00AM) to 24.05.2026 (6.00PM).

During the aforesaid period, the candidates shall login to respective accounts through their application ID credentials and exercise their preferences in the manner indicated below:

1. Programme Preference:

Candidates who have applied for both BAT and BHT programmes shall indicate their preference in order of priority as Preference-1 and Preference-2.

However, in respect of candidates who have applied for only one programme, the same shall automatically be treated as the default preference and no further action shall be required on this account.

2. District Preference:

In terms of the Admission Notification, seats remaining vacant in any district due to non-availability of eligible candidates are liable to be filled from among candidates belonging to other districts of Kashmir Province strictly on the basis of inter-se merit; accordingly, candidates shall also indicate district preferences in order of priority.

The domicile district of the candidate, as reflected in the application form, shall remain automatically locked as Preference-1 by default, and the candidate may thereafter indicate additional district preferences from Preference-2 onwards.

The preferences once submitted shall be treated as final and binding, and no request for modification/change thereafter shall be entertained.

Further, individual e-mail communications in this regard shall also be transmitted to the registered e-mail addresses of the candidates. Any claim regarding non-receipt of e-mail communication or failure to exercise preferences within the stipulated timeline shall not be entertained after expiry of the notified timeline.

All concerned candidates are advised to follow the university official website www.skuastkashmir.ac.in for updates. The schedule for counseling and subsequent admission formalities shall be notified separately in due course of time.
