Subject: Revision of Seat Matrix for admission to BVSc & AH Degree Programme for Academic Session 2026-27-reg.

NOTIFICATION

- Whereas, the University had, vide Admission Notice No.Au/Acad/U-09/2026/443-99 dated 13.04.2026, notified the seat matrix, *inter-alia*, for admission to the BVSc & AH Degree Programme for the Academic Session 2026-27;
- Whereas, the Veterinary Council of India (VCI) has, vide communication No.16-5/2026-VCI/1313-1316 dated 16.07.2026, directed that the intake of the BVSc & AH Degree Programme for the Academic Session 2026-27 be restricted to 75 seats, including All India Quota (AIQ @15%) of 11 seats;

Now, therefore, in view of the aforesaid direction of the Veterinary Council of India, & in order to ensure that admissions are made strictly within the intake approved by the **Competent Regulatory Authority**, the seat matrix notified earlier vide *ibid* Admission Notice is hereby revised to the extent of the seats to be filled under the "Domicile of UT of J&K Category (state share 85%)", as per the following breakup:
