NOTICE

All concerned candidates provisionally allotted seats for admission to various Undergraduate Degree Programmes (Domicile of UT of J&K) for the Academic Session 2026-27 in terms of this office Notice bearing No.AU/Acad./2026/U-09/9654-69 dated 16.09.2026 are hereby advised to view their seat allotment status on their respective applicant dashboards in the admission portal <https://skuastkashmir.in/IUMS/applicant/> from 19.09.2026 (10.00AM).

The candidates provisionally allotted seats are required to book/confirm their allotted seats by depositing a non-refundable amount of Rs.11,000/-, comprising Rs.10,000/- as Seat Booking Fee and Rs.1,000/- as Document Verification-cum-Counselling Fee, through the aforesaid University Admission Portal on or before 22.09.2026 (10.00AM). The Seat Booking Fee of Rs.10,000/- shall be adjusted against the programme fee payable at the time of admission.

Failure to book/confirm the allotted seat within the prescribed timeline shall result in cancellation of the provisional allotment, and the resultant vacancy shall be considered for subsequent round(s) of counselling.

Candidates who book their allotted seats shall to appear before the Counselling Board, in-person, at Nund Reshi Hall, SKUAST-Kashmir, Shalimar Campus, as per the schedule indicated in Annexure to this notice, along with the original documents together with one set of self-attested photocopies thereof, including:

- a. Marks Certificate(s)/Detailed Marks Card(s) of the qualifying examination;
- b. Matriculation/Date of Birth Certificate;
- c. Domicile Certificate;
- d. Reserved Category Certificate, wherever applicable;
- e. University Entrance Test (UET)/ NEET-2026/JEE(Mains)-2026 Score Card, as applicable;
- f. Printed copy of the online application form;
- g. Printed copy of the Admit Card;
- h. Printed copy of the online Preference Submission cum Counselling registration slip;
- i. Printed copy of the Provisional Seat Allotment Letter generated through the University Admission Portal;
- j. Proof of payment of the prescribed Seat Booking Fee (download available through applicant dashboard);
- k. Four (04) recent passport size photographs; and,
- l. Such other document(s)/testimonial(s) as may be required by the University.

The provisional allotment shall remain subject to successful verification of eligibility and original documents/testimonials and fulfilment of all prescribed conditions. The candidature/provisional allotment shall be liable to cancellation in case of failure to report before the Counselling Board, non-production of requisite documents, submission of false/invalid documents, suppression of material information, or any other non-fulfilment of the prescribed eligibility conditions.

Admission shall be deemed to have been confirmed only after successful completion of Document Verification-cum-Counselling, payment of the prescribed fee(s), wherever applicable, and fulfilment of all conditions prescribed by the University.

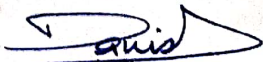

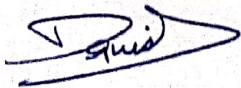
