Subject: Online Registration and Issuance of Smart University Identity Cards

It is hereby notified for the information of all staff members and students that the University is likely to commence the issuance of Smart University Identity Cards from 23rd June, 2026. Accordingly, all staff members and students are advised to complete the Online Registration process at the earliest to facilitate the timely issuance of Identity Cards. The proposed Identity Card is a Smart Identity Solution designed to function as a single-card system across the University campuses including Libraries and shall be managed and administered through the Integrated University Management System(IUMS). Besides serving as an Official proof of identity, the card shall be used at all locations where access control systems are in place. The Smart Identity Card(SID) will facilitate seamless access, enhance security, and support the efficient management of University services.

The Registration Process and Approval workflow shall be as under:

1. The applicant shall register on www.skuastkashmir.in/IUMS, fill in the required information and submit the application online.
2. Upon submission, the application shall become available in the concerned HoD/UG Coordinator Module.
3. The respective Head of the Department (HoD) or UG Coordinator shall verify and approve the application through their respective module.
4. The approved application shall then be forwarded electronically to the Security Officer, SKUAST-K, Shalimar for final processing and issuance of the Smart Identity Card(SID).

The entire process is online and paperless. Applicants can track the status of their application at every stage through their respective personal login module.
